I further understand Standard Form No. 1188, Cancellation of Payroll Deductions for Labor Organization Dues, is available from my <u>Employee Organization</u> and I may cancel this authorization by filing Standard Form 1188 with the payroll office of my employing agency. **Cancellation of this authorization and withdrawing from the Labor Organization can not be accomplished until after the one year anniversary of the date the employee joined the Labor Organization. Such cancellation will not be effective; however, until the first full pay period that begins on or after the next established cancellation date of the calendar year after the cancellation is received in the payroll office.**

Contributions or gifts (including dues) to the labor organization shown above are not tax deductible as charitable contributions. However, they may be tax deductible under other provisions of the Internal Revenue Code
